



APPLE VALLEY MID-WINTER FEST VOLLEYBALL TOURNAMENT

Sunday, February 7, 2010
Co-Rec & Women's Divisions



WHAT: Indoor volleyball tournament with MRPA rules. Six game guarantee. Round robin format (pool play - 2 games to 21 points) with the top teams advancing to a single elimination championship series. Matches will be officiated by registered officials. Tournament rules and rosters will be given out at check-in.

WHERE: Apple Valley Community Center, 14603 Hayes Road. (Hardwood Floor and/or Sport Court Floor)

TIME: Co-Rec matches are tentatively scheduled to begin at 9:00 a.m., with championship play beginning early afternoon. Women's matches are tentatively scheduled to begin at 1:00 p.m., with championship play beginning early evening. **NOTE:** If a female player wants to participate in both tournaments, be aware that Co-Rec playoffs and Women's pool play will overlap.

ENTRY FEE: **\$75.00 for teams currently participating in a 2010 Apple Valley Volleyball League;** \$90.00 for all other teams. **EACH PLAYER is asked to bring a can of food for the local FOOD SHELF!**
**Acceptable forms of payment: Money order, cash, credit card (Visa, Mastercard, Discover only)

DEADLINE: Monday, February 1st at 4:00 pm. **Returning teams from the 2009 tournaments will receive priority, provided they register by Friday, January 22nd.**

AWARDS: **Mid-Winter Fest T-shirts will be awarded for 1st and 2nd place.** Gift certificates to an Apple Valley tavern/restaurant will also be awarded: 1st - \$30; 2nd - \$20.

LIMIT: Registration is limited to 24 teams in each division. Based on the number of entries, the MWF Committee reserves the right to alter the format and/or awards.

LEVEL: Two Divisions are offered: UPPER (MRPA A or B teams) and LOWER (MRPA C or D teams); Apple Valley League teams: A1/A2 teams register for UPPER; B1/B2 teams register for LOWER.
