- WHAT:** Indoor volleyball tournament with USAV rules. Six game guarantee. Round robin format (pool play -2 games to 21 points) with the top 2 teams moving to the upper bracket, and the bottom two pool teams advancing to the lower bracket (if pools fill with three pools and 4 teams in each pool) all 12 teams in each pool will advance to a single elimination championship series. (All 12 teams will advance to the play-offs if we fill with 12 teams in each division.) **Matches will be officiated by registered officials.** Tournament rules and rosters will be provided at check-in.
- WHERE:** Apple Valley Community Center, 14603 Hayes Road. (Hardwood Floor &/or Sport Court Floor) Sponsored by the Apple Valleys Parks & Recreation Department.
- TIME:** **Saturday, Feb. 8th - Co-Rec** matches are scheduled to begin at 8:30 pm with championships play beginning early afternoon. Play-off rounds will be completed by 4-5pm. **Sunday, Feb. 9th - Women's** matches are scheduled to begin on Sunday at 8:30am with championship play beginning early afternoon and complete by 4pm.
- ENTRY FEE:** ***\$110.00 for teams currently participating in a 2020 Apple Valley Volleyball League; \$120.00 for all other teams. PLUS EACH PLAYER is asked to bring a can of food for the local FOOD SHELF! Last year we donated over 600 pounds of food to a local food shelf. Let's top last year's donation!***
**Acceptable forms of payment: Money order, cash, credit card (Visa, Mastercard, Discover only)
- DEADLINE:** Monday, January 27th at 10:00 pm or until filled.
- AWARDS:** **Mid-Winter Fest T-shirts will be awarded for 1st place team.** Gift certificates to an Apple Valley tavern/restaurant will also be awarded: 1st (\$50) and 2nd (\$35) place teams.
- LIMIT:** Registration is limited to 12 teams in each division. Based on the number of entries, the MWF Committee reserves the right to alter the format and/or awards. (6 courts available)
- LEVEL:** Two Divisions/day are offered: UPPER (A or UPPER B teams) and LOWER (Lower B and C teams); *Apple Valley League teams: A1/A2 teams register for UPPER; B1 & below teams register for LOWER.
